## City of Austin Reviews Processes to Ensure Timely Payments to Subcontractors

Austin -- The City of Austin has begun an in-depth review process to assist subcontractors in receiving timely payments from prime contractors on city projects at the behest of the Asian Contractor Association, the Austin Black Contractors Association, and the US Hispanic Contractors Association de Austin.

The issue of timely payment has long besetting the Austin minority subcontracting community when a certain number of primes delayed their payments to subs for up to six months or failed to honor their payments altogether, according to Paul Saldana, Principal of Saldana Public Relations, representing the Hispanic construction community.

Aside from primes' failure to pay, subcontractors, often elated by the new appointments, which can be far and few between, rushed to sign their contracts with primes without fully understanding the terms of payment, explained business owner Carol Hadnot, who also serves as the program manager of the Area Black Contractors Association.

Some of these payment issues to subs are also due to a century old requirement in construction contracts called "retainage," which is the withholding of a portion of each progress payment earned by a contractor or subcontractor until a construction project is complete. Retainage is calculated as a percentage of each progress payment, typically 5% to 10 % of the payment.

Small and sometimes ill-informed subcontractors, who may not have the pecuniary staying power to wait until a project is completed to be fully funded, face cash flow problems or even the threat of bankruptcy.

To help these minority subcontractors, the three minority trade associations have joined forces in urging the city to find checks and balances in their system in order to help subcontractors with their affordability and sustainability in doing business with the city.

Meanwhile, examples of sanctions to primes for failure to pay subs enforced by the cities of Forth Worth and San Antonio were brought forth to Austin city officials for further examination. As a result and a number of ensuing meetings with city officials from various departments, a detailed comparison of ordinances among the three cities was presented in a monthly meeting in November by Veronica Lara, Director of the Small and Minority Business Resources Department.

The document shows all cities have language that addresses possible sanctions against primes for failure to properly pay their subs. Fort Worth and San Antonio go

one step further with additional procedures to check and monitor actual payments from primes to subs, while the City of Austin has no current process in place to verify or ensure such payments to subs.

For example, in Forth Worth, primes face 1)suspension of contract, 2) withholding of funds, 3) recission of contract, and 4) disqualification for failing to honor payments to subs. (Ordinance 2010-06-17-0531) In San Antonio, primes' failure to pay subs authorizes the city to withhold future payments and/reject future proposals until compliant. (Ordinance No. 20020-12-2011)

To properly monitor prime payments to subs, the City of Fort Worth utilizes B2Gnow, a financial system of record, to capture reporting of payments. The system allows subs to report back confirmation of payments or any disputes with primes. With similar de facto constraint, the City of San Antonio requires that primes present a copy of the check paid to the sub, copy of the paid invoice, or affidavit confirming payment received by the sub, according to the document.

The contract rule used for the City of Austin in the comparison states that the City of Austin "may" reject a prime's bid if there is "evidence of failure to pay subcontractors, suppliers, or employees." In the case of "failure of Contractor to make payments properly to subcontractors," another rule states, the city "may withhold or nullify the whole or part of payment," to the general contractor.

As to how and if the City of Austin will gather "evidence of failure to pay," the city's contract rules left it undefined and open for interpretations.

Ms. Lara working with Contract Management and Public Works has added new process regarding payments to subs for implementation including: 1) Public Works Accounts Payable to attend preconstruction meetings, 2) Contract language requiring primes to notify subs when their invoices are rejected, 3) Tip sheets to primes and subs to include payment and payment resolution between them.

Other actions to be considered by the city in the future include requiring primes to host preconstruction meetings with their subs to go over payment terms in the presence of city officials; city staff will evaluate and revise contract language including withholding of future work from primes until payment issue is resolved.

ACA will continue to engage in the discussions and report back to the community any progresses or changes made to improve timely payments to subs.
